I generally function within rational emotive, human development and cognitive behavioral frameworks. As a Christian I am aware of the influence our values have on our individual and family functioning. I strive to assist clients in understanding, clarifying and applying their values to their own life needs. I subscribe to and will abide by the Codes of Ethics of the National Board of Certified Counselors, the Christian Association for Psychological Studies, and the Oregon State Board of Licensed Professional Counselors and Therapists.

### Education and Training:

### **Philosophy and Approach:**

I offer professional psychological services to individuals, couples and families. My primary clinical focus is couple's therapy utilizing Emotionally Focused Therapy (EFT) modality and Intersubjectivity Psychoanalysis (IS). EFT intervention consists in helping the distressed couple and individuals to form a new bond, which becomes an attachment foundation that empowers the couple and the individual to work through various relational and psychological issues. I also do psychotherapy informed by IS which is the fifth-generation psychoanalysis with its profound shift to two-person psychology. I have 40+ years of pastoral counseling experience working with individuals & couples and am qualified to do integrative counseling regarding people's Image of God (IOG), combining both psychological work and spiritual work within the framework of the Christian Faith. I do executive coaching assisting professionals (small business owners, pastors, LPC & MFT clinicians and graduate counseling students) to grow personally and professionally.

I also provide clinical supervision for registered interns and licensed counselors and therapists who are interested in developing theoretical and clinical skills utilizing my hybridized theory: EFT, IS and IOG with foundations in Neuroscience and Attachment Theory.

### **Formal Education:**

I hold two Masters Degree: M.Div. from San Francisco Theological Seminary, and a M.S.MFT from Fuller Theological Seminary School of Psychology. I also hold a Ph.D. in MFT from Fuller. I have received Externship training from Dr. Sue Johnson at the University of Ottawa, Canada in EFT and advanced EFT training in Seattle. I served from 2006-14 as an associate professor at George Fox University in their Graduate School of Counseling. I served at Multnomah University as the Director of their master's degree program of counseling in 2014-2015. I am currently serving as the Founder-President of NWIICT, which conducts research, provide supervision, training & coaching and provide mental health counseling and therapy to a diverse set of clients.

### **Nature of Supervision**
